**Re: Site Investigation Notice –
Royal Canal Towpath Closure and
Cross Guns Bridge Temporary Lane Closure**

Dear Resident/Business,

GRAHAM Construction, on behalf of the National Transport Authority (NTA), is beginning construction on the Ballymun/Finglas to City Centre Core Bus Corridor Scheme. BusConnects is a transformative city-shaping initiative designed to make bus journeys more reliable and efficient, while also delivering major improvements to cycling and pedestrian infrastructure across the Greater Dublin Area.

We are writing to inform you that site investigation works are scheduled to take place in your area to assess the ground conditions and structural requirements for planned future works. These investigations will be carried out on the **Royal Canal towpath** between **3 August and 7 August 2026**. Standard working hours will be **7:30am to 11:00pm**, and all site investigation activities will be confined to the **Royal Canal towpath**.

Please note that the **Royal Canal towpath** will be **closed from Monday, 3 August to Friday, 7 August 2026** to accommodate these essential works. Appropriate signage and diversion information will be provided.

To facilitate these works, equipment will be delivered and tracked onto the towpath on **Monday, 3 August 2026** and removed on **Friday, 7 August 2026**. To ensure the safe delivery and installation of the equipment, a **temporary lane closure** will be required at **Cross Guns Bridge** for approximately **15 minutes**. The closure will take place between **4:45am and 5:30am on Monday, 3 August 2026**, and between **7:30pm and 11:00pm on Friday, 7 August 2026**. Traffic management operatives will be in place to minimise the disruption and maintain safety for all road users.

In advance of this project moving to construction, we will continue to proactively communicate clear details of the project to the local community and to relevant stakeholders in the area. We regret any inconvenience these necessary works may cause.

Tá GRAHAM Construction, thar ceann an Údaráis Náisiúnta Iompair (ÚNI), ag tosú ar an obair thógála ar Scéim Chroíchonair Bhus ó Bhaile Munna/Fionnghlas go dtí an Lár. Is tionscnamh claochlaitheach é BusConnects lena gcuirtear le cruth na cathrach atá beartaithe le turais bhus a dhéanamh níos iontaofa agus níos éifeachtaí agus lena gcuirtear feabhsuithe móra ar an mbonneagar rothaíochta agus coisithe freisin ar fud Mhórcheantar Bhaile Átha Cliath.

Táimid ag scríobh chugat chun tú a chur ar an eolas go bhfuil sé beartaithe tús a chur le hoibreacha imscrúdaithe láithreáin i do cheantar chun na coinníollacha talún agus na riachtanais struchtúir a bhaineann leis na hoibreacha beartaithe seo a aithint don todhchaí. Déanfar na himscrúduithe seo ar **chosán tarraingthe na Canálach Ríoga** idir **an 3 Lúnasa agus an 7 Lúnasa 2026**. Beidh na gnáthuaireanta oibre idir **7:30am go 11:00pm**, agus coinneofar gníomhaíochtaí imscrúduithe láithreáin uile ar **chosán tarraingthe na Canálach Ríoga**.

Tabhair faoi deara go mbeidh **cosán tarraingthe na Canálach Ríoga** dúnta ó **Dé Luain, 3 Lúnasa go Dé hAoine, 7 Lúnasa 2026** chun na hoibreacha riachtanacha seo a chur san áireamh. Cuirfear comharthaíocht chuí agus eolas maidir le malairt slí ar fáil.

Chun na hoibreacha seo a chur san áireamh seachadfar trealaimh agus iomprófar chuig an gcosán tarraingthe é **Dé Luain, 3 Lúnasa** agus bainfear an trealaimh **Dé hAoine, 7 Lúnasa 2026**. Chun seachaid agus suiteáil shlán na dtrealamh a chinntiú, tá **dúnadh lána sealadach** ag teastáil ag **Droichead Cross Guns** ar feadh thart ar **15 nóiméad** don seachadadh agus don bhaint araon. Beidh an dúnta ag tarlú idir **4:45am agus 5:30am Dé Luain, 3 Lúnasa 2026**, agus idir **7:30pm agus 11:00pm Dé hAoine, 7 Lúnasa 2026**. Beidh oibrithe bainistíochta tráchta i bhfeidh chun an cur isteach a laghdú agus chun an sábháilteacht a choinneáil do gach úsáideoir bóthair.

Sula gcuirfear tús le céim thógála an tionscadail sin, leanfaimid orainn ag cur shonraí soiléire an tionscadail in iúl go réamhghníomhach don phobal áitiúil agus do na páirtithe leasmhara ábhartha sa cheantar. Gabhaimid leithscéal as aon mhíchaoithiúlacht a d'fhéadfadh eascairt as na hoibreacha riachtanacha sin.
